

**CONSENT AND AUTHORIZATION TO PERFORM BACKGROUND INVESTIGATION
INCLUDING CHECK OF CRIMINAL HISTORY RECORDS**

I hereby grant unconditional permission to Lubbock County Water Control and Improvement District No. 1 (District) to perform an investigation of my personal and professional background, which will entail obtaining a copy of my credit report from one or more credit reporting agencies, including, but not limited to: (i) Equifax; (ii) Experian; and /or (iii) TransUnion. I also hereby grant unconditional permission to District to obtain documents and other information regarding my criminal history. I hereby acknowledge my understanding that this investigation may yield information including, but not limited to: delinquent debts; judgments or other public records, including bankruptcy; arrests; convictions; plea bargains; deferred adjudications; information that I may have thought expunged; and delinquent conduct committed as a juvenile.

I further acknowledge my understanding that the information derived from this investigation will be used, in part, to determine my eligibility to Lease or Sub-Lease property owned by the District.

I understand that I will have an opportunity to review the reports that District obtains as part of its investigation upon request.

I also understand that the District may, from time to time, and solely at its discretion, repeat this investigation in part, or in its entirety; and I hereby grant unconditional permission to District to perform ongoing investigations of my personal and professional background, including obtaining documents and other information regarding my credit and criminal history.

I hereby affirm that all of the information I have disclosed during this pre-Leasing process is truthful in character and comprehensive in scope. I have not withheld or concealed, in part or in full, any information that could unfavorably affect my application. I understand that if I have withheld or concealed, in part or in full, any requested information in this Consent and Authorization, or in any phase, element, or document associated with applying to Lease or Sub-Lease District property, that I am subject to any Lease or Sub-Lease being immediately terminated, regardless of when it is discovered that I withheld or concealed this information.

I, the undersigned, do for myself, my heirs, executors and administrators, hereby release and forever unconditionally discharge and hold District harmless from, and fully indemnify District and each of its members; shareholders; officers; directors; employees; agents; and/or owners, with regard to any and all causes of actions; suits; liabilities; costs; debts; demands (including claims for negligence, gross negligence, and strict liability); and any and all related attorney's fees; court costs; or any other expenses resulting from the investigation of my background and/or in connection with my application for the Lease or Sub-Lease of property owned by the District.
